Access to Medicinal Cannabis

Both Commonwealth and State legislative changes in the past year have paved the way for the cultivation, production and supply of medicinal cannabis in Australia. While a number of cultivation and manufacturing licences have been issued, at this stage, locally produced medicinal cannabis products are not yet available.

However, supplies of imported medicinal cannabis are now available in Australia. The Office of Drug Control has approved five authorised importers, who are importing about 19 different products. Details are on their [website](#).

PBS Hospital Review

The Department of Health has engaged Australian Healthcare Associates (AHA) to conduct the PBS Pharmaceuticals in Hospitals Review. This review aims to examine issues around existing procurement, prescribing, dispensing and claiming of PBS benefits in hospitals. As a member of the Council of Australian Therapeutics Advisory Groups (CATAG), Kent Garrett (VicTAG President) and Greg Weeks (VicTAG Secretary) attended a teleconference with AHA consultants to provide feedback on the use of the PBS in Hospitals.
