Medicines with Special Pricing Arrangements

Kent Garrett, VicTAG President and Director of Pharmacy, Austin Health, attended a Technical Working Group meeting in Sydney, to discuss changes to the Special Pricing Arrangements funding model. There are five funding models that have been proposed and one of the models will be implemented. The Commonwealth's desired implementation date is 1st July 2019, however this will depend on interfaces and software system changes being ready by this time. Snake and spider antivenom stock holding recommendations

VicTAG have contributed to an important piece of work led by Safer Care Victoria to evaluate stock holdings of snake and spider antivenoms in Victoria. This work has now been published on the Safer Care Victoria website (link below) and provides guidance on minimum stock holdings of antivenoms as well as information on the best location for care to be provided.

SafeScript

Following on from the joint VicTAG and SHPA response submitted in March 2018, both organisations were invited to meet with the SafeScript project team. There it was requested that consideration be given to an exemption for short courses of opioids (5 days supply or less), provided on discharge from hospital, to assist with reducing the impact on hospital discharge workflows, particularly for surgical areas. VicTAG submitted a letter requesting this exemption in August 2018 which will be considered by the Expert Advisory Group.
