## DHHS COVID-19 Health Services Pharmaceutical Reference Group

The work of the Reference Group is now being finalised. In addition to the development of the Pharmaceutical Reserve, another initiative implemented was the reporting of stock holdings from each Victorian public hospital pharmacy store. This report provides visibility of stock of various medicines across Victoria, something that was not previously possible.

# **Emergency and Life Saving Medicines Register**

A November 2020 update of the Emergency and Life Saving Medicines (ELSM) Register has been uploaded to the website. As a part of the regular review process, each hospital is requested to please conduct a check of your hospital's stock levels against the list on the <u>ELSM Register</u>. Some information from the Victorian Poisons Information Centre would like to pass on to VicTAG members are as follows:

- <u>Clinicians Health Channel</u> provides access to a number of Toxicology resources including the Austin Toxicology Guidelines (also available as an App), TOXINZ and Poisindex.
- Paraquat Dithionite Test Kits are used to assist the diagnosis of paraquat exposure/poisoning. Syngenta provides these test kits free of charge and they should be stocked in ALL Emergency Departments. To arrange for a test kit and treatment guide, email <u>sydney.reception@syngenta</u>.com
- Be aware that street "Xanax" may substances other than alprazolam. Refer to <u>NSW Health Safety</u> <u>Notice</u> for further information and a list of possible substances contained.
- Emergency Flucytosine stock is being held by Western Health, refer to the <u>ELSM page</u> on the VicTAG website for details on how to obtain supply.

## **Medication Safety Alerts**

There were 17 responses received to the survey circulated on Medication Safety Alerts. Some points of interest from the responses were as follows:

- Many hospitals printed and displayed the posters in clinical areas, others used the information to create their own hospital specific alert and they were also used as supporting documents for accreditation.
- The most used posters were Giving 3 or more? First make sure!, APINCH alert and High concentration insulin products.
- 94% of respondents wanted to see the Alerts program continue
- Respondents wanted to see a shift of focus to alerts that are more directed/related to
  electronic medicines management and more timely in completion for new/critical topics

The results have been tabled at the VicTAG Management Committee who are working to revamping the program to address the feedback provided.

## **Council of Australian Therapeutic Advisory Groups (CATAG)** Update

CATAG, as part of the ViP bDMARDS program, has now released a <u>Position Statement on the use of</u> <u>low-dose methotrexate</u> which provides guidance on dispensing and administering low-dose methotrexate.

NPS MedicineWise have also launched a <u>bDMARDS webpage</u> which contains information about the broader project and the first release of resources for rheumatological conditions.

#### **Pharmaceutical Waste Management Project**

This VicTAG project, led by Grace Wong, Western Health, has now been completed. The project aimed to develop a Victorian Framework for handling and disposal of Pharmaceutical Waste. The framework provides guidance for the identification, segregation, handling, storage and disposal of pharmaceutical waste generated by health services.

Grace formed and led the VicTAG Pharmaceutical Waste Advisory Group, a team of experts in the field, to develop the Framework. The individuals are acknowledged in the document and VicTAG is grateful for their important contribution to this work.
